

# OPT-OUT REQUEST FORM DATA REMOVAL PROCEDURE

PopuTrust is where individuals go to take back control of their online identity and sensitive personal data. As a meta-search-engine PopuTrust allows customers to search at just one location for multiple sources of digital content. Data is sourced from dozens of government, private, and public records sources (US Census Bureau, Bureau of Labor, Court Records, Town Records, etc.) As a data aggregator, PopuTrust does not guarantee the accuracy of any information.

We understand users may wish to remove data from our web servers and our various source databases – in order to do so, this form must be completed fully and as instructed to comply with security protocols. Visit [popustrust.com](http://popustrust.com) for data privacy policy and additional services to remove data from 3<sup>rd</sup> party databases.

Removal from PopuTrust will not remove data from our source databases. Note that processing time is 30 days and repeat requests will create delays. This form must be faxed to: +1 (617) 208-2481. Incomplete forms, telephone requests, email requests, or forms without a Notary Stamp and/or necessary supporting documentation or ID scans will be ignored.
